2017-2018 Vocational Rehabilitation Documentation of Assistance

Students receiving educational assistance for tuition and fees from a vocational rehabilitation program are required to provide the Student Financial Aid Office with **documentation of additional assistance received**, including assistance which may be paid directly to the student (such as expenses for books, supplies, room, board, housing, maintenance, and transportation).

The Financial aid office will request documentation of benefits from each student who receives tuition and fees support from a vocational rehabilitation program at the beginning of each semester **before releasing any federal, state, or institutional financial aid**. Documentation of benefits must be confirmed by the student's vocational rehabilitation counselor. Counselors may provide documentation to the student by using this form to document assistance received **or must confirm if the student is not receiving or not expected to receive any assistance other than tuition and fees**.
